The battery is designed to preclude violent rupture under normal conditions incident to transport. The TLP-91121/A battery may come with optional suffixes consisting of a "/" followed by one or more letters and a digit. These suffixes indicate different types of finishing to the battery, e.g. harness. Tadiran manufactures all cells/batteries under a quality management system as required under this regulation.
