(iv) **Description:** Primary (non-rechargeable) 7.4 V Lithium Thionyl Chloride (Li-SOCl₂) hybrid battery, assembled from a group of 1 (one) "D" size cell and 1 (one) HLC-1530 cell in parallel connection and 2 groups of this in serial connection. Dangerous reverse current between the parallel D cells and HLC-1530 does not occur because of presence of parallel diode in each group.
 The TLP-93211/B battery may come with optional suffixes consisting of a "/" followed by one or more letters and a digit. These suffixes indicate different types of finishing to the battery, e.g. harness.
